To Be Raced As:

Eight races as follows:

2-Year-Olds:

E. H. Harriman Cup..... Trotting Colts (and Geldings)
Acorn Stake..... Trotting Fillies
Goshen Cup..... Pacing Colts (and Geldings)
Debutante Stake..... Pacing Fillies

3-Year-Olds:

Historic-Dickerson Cup..... Trotting Colts (and Geldings)
Coaching Club Trotting Oaks..... Trotting Fillies
Jersey Cup..... Pacing Colts (and Geldings)
The Ladyship Stake..... Pacing Fillies

To Be Raced At:

Tioga or Vernon Downs in N.Y. Definite dates will be published in the USTA Stakes Guide in the year of the races. If for any reason it becomes impractical or undesirable, in the opinion of The Hambletonian Society (Society), to hold either one or more of these races at the track designated, the Society reserves the right to change the date and/or the location of either any or all races.

Cancellation:

The Society further reserves the right to cancel either one or more of the races if for reasons beyond its control it becomes impractical or undesirable in the opinion of the Society to conduct said race or races. If an event is not raced due to circumstances beyond its control, the Society's responsibility and liability will be limited to refunding without interest nomination, sustaining and entrance fees collected toward canceled events that have not been disbursed at the time of cancellation. If canceled after the first 2-year-old payment, these monies will be pro-rated among the owners of the horses eligible at the time of cancellation. If canceled prior to the first 2-year-old payment, the nomination fees will be refunded to the nominators.

PURSE:

Actual 2010 total purses were:

2-Year-Old Colt Trot	\$88,200	(2 divisions)

3-Year-Old Filly Trot	\$72,361	(1 division)
3-Year-Old Colt Pace	\$75,450	(2 divisions)
3-Year-Old Filly Pace	\$77,661	(2 divisions)

Note: Because of lower payment amounts beginning in 2012, total purses may be less. Added money remains the same as in 2011.

ADDED MONEY:

Tioga Downs will add \$20,000 to the 2-year-old events and \$30,000 to the 3-year-old events.

Nomination Fee:

May 15, 2011\$15 (U.S. funds only)

Nominated horses must be properly identified to the satisfaction of the Society at the time of nomination, including but not limited to certifying that the nominated horse is registered as a twin or is the only foal of the mare in 2010. The Society will not recognize foals as twins if produced through embryo/ovum transfer. If produced through embryo/ovum transfer, only the donor mare's first born foal in 2010 will be eligible for nomination. The Owner(s) of the nominated horse agree to indemnify and hold the Society and the Sponsor harmless from any and all claims, suits or damages, including attorney's fees, arising out of or related in any way to such certification.

Supplemental Nominations:

Foals not nominated in the May 15, 2011 yearling payment, may be made eligible by a supplemental nomination fee of \$1,000, due on or before March 15, 2012. Supplemented horses may declare as a 2-year-old, subject to the designated entrance fee and will be eligible to the 3-year-old event if they make the February 3-year-old payment. Two-year-old supplemental nominees do not have to pay the normal March 15 sustaining fee.

March 15, 2012 2YO Supplemental Nomination Fee.....\$1,000

Ineligible 3YO's may be made eligible by a supplemental nomination fee of \$2,000, due on or before February 15, 2013. Supplemented horses may declare as a 3-year-old, subject to the designated entrance fee. Three-year-old supplemental nominees do not have to pay the normal February 15 sustaining fee.

February 15, 2013 3YO Supplemental Nomination Fee.....\$2,000

Future Payments: (U.S. Funds only)

On 2-Year-Olds:

March 15, 2012 Sustaining Fee.....\$400
Entrance Fee.....\$1,000
Entrance Fee (if 2 or more divisions).....\$500

On 3-Year-Olds:

Feb. 15, 2013 Sustaining Fee.....\$600
Entrance Fee.....\$1,500
Entrance Fee (if 2 or more divisions).....\$750

Future Eligibility:

The March 2-year-old payment, as well as the February 3-year-old payment, must be made to remain eligible for the 3-year-old events.

Declaration:

Entrance fee shall be due with declaration to start at the time and date posted on the Tioga Downs/Vernon Downs condition sheet.

Entrance fee shall be due at time of declaration and payable not later than one hour prior to post time of the race to be contested. All entrance fees shall be made payable to Tioga Downs

Filly Notice:

Fillies are not eligible to the colt races.

Supplemental Declarations:

There are no supplemental declarations allowed for any of these races.

Payment Distribution:

Nomination fees will be divided equally among the eight races. All other payments will be credited to the specific race.

Transfer:

Eligibles changing gait may be transferred at any time. Payments already made remain with the original gait.

Notice:

USTA Rule 11, Section 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event." The Hambletonian Society, Inc. will construe payment to require that cash or check duly honored upon presentation be received at the time specified in USTA Rule 12, Section 4.

WAIVER:

As a condition of participation in the Historic Series No. 45, the Owner(s) of the nominated horse(s) hereby grants to the Society, its representatives, successors, and assigns the absolute right to copyright and publish, use or reuse still and motion photographic images of its horses, drivers, trainers, employees, officers and agents, in whole or in part, in composite or in distorted character, with or without use of names, in color or otherwise, for the purpose of promotion, advertising, trade or other lawful purpose in any and all media. Owner(s) waives any right to inspect and/or approve the finished product or the copy that may be used in connection therewith or the use to which it might be applied. Owner(s) further agrees to inform his drivers, trainers, employees, officers and agents of the authority granted to the Society herein,

to hold Society harmless from any and all liability and damages, and to indemnify the Society from same should any such owner(s), driver(s), trainer(s), employee(s), officer(s) and agent(s) challenge Society's rights as set forth above.

Racing Conditions:

All events will be raced as one dash at one mile. If the number of horses declared in to start exceeds the limits prescribed by the current USTA Rules (14 on a mile track), the 2-year-old events will be raced in divisions, and the track may elect to race the 3-year-old events in either elimination heats or divisions.

All starters are subject to the detention policy of the race track.

Money Division:

Purses for all races will be divided 50-25-12-8-5%.

Drivers and Trainers Fees:

The drivers and trainers fees may be disbursed in accordance with the policy of the track at the time of the race.

Disputes:

In the case of any dispute as to the interpretation of these conditions, the decision of the Executive Committee of The Hambletonian Society, Inc. shall be final. All fees and payments in any race are accepted on the condition that all claims, objections and appeals arising out of these races or with respect to any interpretation of any rules or conditions of the races, or otherwise shall be decided by Executive Committee of the Hambletonian Society, Inc.

Rules:

Unless otherwise specified and except as may be affected by New York State Racing and Wagering Board, Harness Racing Division, Rules and Regulations rules, USTA rules not in conflict with these conditions to govern, as well as the track rules and regulations of Tioga Downs. The rules shall be those in effect at the time of the race.
