

LANDMARK STAKE NO. 29

Eight Separate Open & Filly Races

For 2-Year-Old Trotters & Pacers in 2011; 3-Year-Olds in 2012

OWNED AND SPONSORED BY: Goshen Historic Track, Inc.

SERVICED BY: The Hambletonian Society, Inc.

FOR: Foals of 2009 (Subject to U.S.T.A. Foaling Date Rules).

TO BE RACED AS: Eight races. Open and Filly divisions for 2-year-old and 3-year-old trotters and pacers.

TO BE RACED AT: Goshen Historic Track, Goshen, N.Y. during the Grand Circuit Hall of Fame Days. Definite dates will be published in the *U.S.T.A. Stakes Guide* in the year of the races. If for any reason it becomes impractical or undesirable, in the opinion of the Sponsor, to hold either one or more of these races at the track designated, the Society reserves the right to change the date and the location of either any or all races.

CANCELLATION: The Sponsor further reserves the right to cancel one or more of the races if for reasons beyond its control it becomes impractical or undesirable in the opinion of the Sponsor to conduct said race or races. If an event is not raced due to circumstances beyond its control, the Sponsor's responsibility and liability will be limited to refunding without interest such yearling nomination, sustaining and entrance fees as it has collected toward canceled events that have not been disbursed at the time of cancellation. If canceled after the first 2-year-old payment, these monies will be prorated among the owners of the horses eligible at the time of cancellation. If canceled prior to the first 2-year-old payment, the nomination fees will be refunded to the nominators.

ADDED MONEY: Goshen Historic Track, Inc. will add a minimum of \$30,000 divided as follows, or 10% of the total amount paid in by horsemen in each event, whichever is greater: \$5,000 to each of the four Open events and \$2,500 to each of the Filly events.

NOMINATION FEE: May 15, 2010 \$10 (U.S. Funds only)

Nominated horses must be properly identified to the satisfaction of The Hambletonian Society at the time of nomination.

SUPPLEMENTAL NOMINATIONS: Two-year-old colts not nominated in the May 15, 2010 yearling payment, may be made eligible by a supplemental nomination fee of \$300, due on or before March 15, 2011. Two-year-old fillies not nominated in the May 15, 2010 yearling payment, may be made eligible by a supplemental nomination fee of \$200, due on or before March 15, 2011. Such supplemented horses may declare as a 2-year-old, subject to the designated entrance fee and will be eligible to the 3-year-old event if they make the February 3-year-old sustaining payment. Two-year-old supplemental nominees do not have to pay the normal March 15 sustaining fee.

Otherwise not eligible 3-year-old colts may be made eligible by a supplemental nomination fee of \$750, due on or before February 15, 2012. Three-year-old fillies may be made eligible by a supplemental nomination fee of \$400, due on or before February 15, 2012. Such supplemented horses may declare as a 3-year-old, subject to the designated entrance fee. Three-year-old supplemental nominees do not have to pay the normal February 15 sustaining fee.

FUTURE ELIGIBILITY: The March 2-year-old payment as well as the February 3-year-old payment, must be made to remain eligible for the 3-year-old events.

DECLARATION: Entrance fee shall be due with declaration to start at the track where the race is being held at the time and date designated by the track. At no time will that declaration deadline be prior to four (4) days before the date of the race. It is the intention of the track to draw both the 2-year-old and 3-year-old races each year on the same day.

Entrance fee shall be due at time of declaration and payable not later than one hour prior to post time of the race to be contested. All entrance fees shall be made payable to the Hambletonian Society, Inc. At time of declaration, a horse must show at least one (1) performance line without a break within thirty (30) days prior to the advertised day of the race that meets the qualifying standards of the track where the line was charted. Eligible horses must meet these standards at the time of entry or entry will be refused with no refund of nomination and sustaining payments.

FILLY NOTICE: A filly which is properly nominated and sustained, but not declared to start in the Filly Division, may start in the Open race upon 1) proper declaration and 2) payment of a) the entrance fee required for the Open race plus b) the difference between any lower nominating and sustaining fees for the Filly Division and the higher nominating and sustaining fees for the Open race. In such event previous payments in the Filly Division shall remain therein and shall be forfeits. A filly may not declare or enter in both races.

Filly Declaration for the Open.....\$175 plus Entrance Fee

SUPPLEMENTAL DECLARATIONS: There are no supplemental declarations allowed for any of these races.

PAYMENT DISTRIBUTION: Nomination fees will be divided equally among the eight races. March 2-year-old payments will also be divided equally; on fillies, among the four filly races, and on colts, among the four colt races. Other payments will be credited to the specific race.

TRANSFER: Eligibles changing gait may be transferred at any time. Payments already made remain with the original gait.

NOTICE: U.S.T.A. Rule 11, Section 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event." The Hambletonian Society, Inc. will construe payment to require that cash or check duly honored upon presentation be received at the time specified in U.S.T.A. Rule 12, Section 4.

WAIVER: As a condition of participation in the Landmark Stake No. 29, the Owner(s) of the nominated horse(s) hereby grants to the Sponsor, its representatives, successors, and assigns the absolute right to copyright and publish, use or reuse still and motion photographic images of its horses, drivers, trainers, employees, officers and agents, in whole or in part, in composite or in distorted character, with or without use of names, in color or otherwise, for the purpose of promotion, advertising, trade or other lawful purpose in any and all media. Owner(s) waives any right to inspect and/or approve the finished product or the copy that may be used in connection therewith or the use to which it might be applied. Owner(s) further agrees to inform his drivers, trainers, employees, officers and agents of the authority granted to the Sponsor herein, to hold Sponsor harmless from any and all liability and damages, and to indemnify the Sponsor from same should any such owner(s), driver(s), trainer(s), employee(s), officer(s) and agent(s) challenge Sponsor's rights herein as set forth above.

RACING CONDITIONS: All events to be raced as one dash at one mile. If more than 11 are declared in to start, the events will be raced in divisions.

All starters are subject to the detention policy of the race track.

MONEY DIVISION: Purses for all races will be divided 50-25-12-8-5%.

DISPUTES: In the case of any dispute as to the interpretation of these conditions, the decision of the Sponsor shall be final. All fees and payments in any race are accepted on the condition that all claims, objections and appeals arising out of these races or with respect to any interpretation of any rules or conditions of the races, or otherwise shall be decided by the Sponsor.

RULES: Unless otherwise specified, the Rules & Regulations of the New York State Racing & Wagering Board, Harness Racing Division to govern, as well as the Rules & Regulations of Goshen Historic Track. The rules shall be those in effect at the time of the race.
